Another new trout season Opening Day is in the books! We are off to a good start.

Our chapter helped the PA Fish and Boat Commission stock our TU project waters and other Dauphin and Lebanon County streams, and the creeks are holding more than enough water to go around. The fish that were put in look great, and better yet, many are taking artificials.

We further readied ourselves for the season by teaching a Beginner and an Advanced Fly-Tying course. In March, we held our first "in-person" general membership meeting in over two years, and it was great to see so many faces, old, and even new ones. The Executive Committee of our Board of Directors met in mid-April to lay out our chapter's calendar for the upcoming year, and this information will be shared with all our members at our May meeting. One of the main focuses for this year will be to reignite our chapter's volunteer force. We have some work planned on our special chapter project waters, tree planting, log removal, clean-up, and wish to have our chapter members show up en masse to maintain a healthy stream environment. We wish to establish a Youth Mentoring program and find a chairperson within our ranks. We had no takers this year for the Rivers Conservation Camp at Messiah University, and TU national has established a "youth leadership conference", which we have agreed to support. I would love to see us create a Fly-Fishing Scouting Merit Badge counselor within our membership, and the PA Fish and Boat is willing to work with us to create a group of "certified" fishing instructors. These are all fantastic opportunities to get us back into touch with younger people, for which there was no contact the last two years.

Although we did not have a Spring banquet again, we had a very successful Spring raffle, with six excellent prizes. We raised \$7,000.

## Fly-Tying Courses

This past winter, the chapter sponsored two fly-tying courses, a beginner's course, and an advanced tying course. The two programs – 6 weeks each – met on the same nights in the Palmyra Sportsmen's Association clubhouse. A total of 14 tiers registered and took the courses, 11 of them in the beginner's group and 3 in the advanced class. Of these, it was interesting to note that five of the students were women; the highest number of females to take the course.




Special thanks to Chuck Swanderski for coordinating the Beginner's class, and to Rich DiStanislao for leading the Advanced class.

A dozen chapter members helped throughout the length of the program, serving as "mentors" and adding their assistance and expertise at the vise. You really can't teach a course without the help of these mentors. Several mentors rotated as lead tiers with the Beginner class.

#### **TU Volunteers Stock Special Regs Streams**

In cooperation with Doug Deppen and Mark Sweppenhiser, the WCO's in Lebanon and Dauphin Counties, Doc Fritchey volunteers, including a good sized group of "newbies," helped stock the special regulations sections of the Ouittie and Manada Creeks in March/ April.



Included in the fish for the Quittie were a significant number of larger trout for the program the Fish and Boat Commission calls Keystone Select.

On Saturday morning, April 16<sup>th</sup> it was fun to watch fly fishermen of all ages and sizes

catching and releasing the browns and rainbows that had been stocked just a few days before, with numerous stories of large fish that took tiny nymphs under the surface.

We extend our thanks to everyone that helped stock our local trout streams. We'll be back at it in the fall on both streams.

#### **Grant Requests/Projects Progress Report**

Russ Collins recently advised the TU board of the status of the projects he and his small team are working on in the Hammer Creek watershed in SE Lebanon County and several projects in Lebanon and Dauphin Counties. It's an exciting time of grant writing, land-owner negotiations, volunteer and consultant discussions, and implementation.

Hammer Creek-Shuey property - Received National Fish & Wildlife Foundation approval of the workaround on a bog turtle habitat issue/problem. We are now awaiting DEP approval to move forward with the project.

Hammer Creek-Zimmerman property - DEP received our permit reapplication after redoing a new wetlands delineation and phase 1 bog turtle study. Now it's a waiting game till the permit is approved.

Hammer Creek-Barry property -Two months ago we installed groundwater wells and a stream water temperature logger to gather data to confirm the plan of relocating the entire creek to the adjacent wetlands area; to increase the cold water input to the stream. Rob Smith has assumed leadership of this effort and is leading a team to collect the data each month.

Hammer Creek-Fisher Farm - We submitted a grant request to National Fish and Wildlife Foundation for a small watershed implementation grant of \$271,630 on the Hammer with the cooperation of an Amish farmer; to restore a tributary on his property. The initial design process has been completed by US Fish and Wildlife - thanks to Adam Smith and Bob Vierck (USFW).

**Hammer Creek**- Two additional projects are in discussion with property owners on an unnamed tributary locally referred to as Old Mill Run or Distillery Run. Stay tuned, exciting things happening, with more to come.

Spring Creek Hershey area - We received and have accepted a grant of \$132,000 for the creation of a Watershed Implementation Plan (WIP). The creation of the Watershed Implementation Plan (WIP, also known as APR-Alternate Restoration Plan) is under way and the various sub-consultants have begun submitting their parts of the combined effort. It will take nearly a year to complete the work. Eventually, a non-profit, Watershed Association will be created to restore the creek.

**Bachman Run Horst/Bachman properties** - We received a grant of \$161,000 for streambank restoration.

# **Growing Greener Grants in Lebanon County**

As part of the 2021 Growing Greener grant awards, (Growing Greener is the single largest investment of state funds that goes directly towards addressing critical environmental concerns of the 21st century) projects associated with two Lebanon County creeks will receive more than \$370,000 in total funding for restoration efforts.

A Quittapahilla Creek floodplain restoration project in North Cornwall Township will receive \$110,500 towards a functional floodplainwetland system that will provide better flood storage, water quality benefits, and significant reductions in sediment load.

In South Londonderry Township, a similar effort for Killinger Creek will receive \$260,000 for a 1,600 foot streambank stabilization project that will significantly reduce sediment and protect the stream channel and wetlands corridor.

These Lebanon County projects are two of 65 funded through the Department of Environmental Protection's \$18.2 million funding round as part of the 2021 Growing Greener program.

# **Keystone Coldwater Conference held in February**

On a cold weekend at the end of February, three of our chapter's Executive Committee – Collins, Pennell, and DiStanislao - attended the annual Keystone Coldwater Conference in State College. This biennial conference was cohosted by the Pennsylvania Council of Trout Unlimited and by the Pennsylvania Chapter of the American Fisheries Society.

This well attended two-day event featured speakers and presentations on conservation, development of volunteers, recruiting members from diverse backgrounds, poster sessions with matching discussion groups led by college faculty and college students, and exhibit booths. The Pennsylvania Fish and Boat Commission was also on hand to lead several discussions. Our own chapter continues to receive recognition for the good work that we are doing with our projects, the Diversion Well, and with grants for stream improvements.

#### **Schaeffer Visits Stony Valley**

It could not have been a worse evening in April (cold with two inches of snow) to drive into Stony Valley to visit the chapter's diversion wells but Tim Schaeffer, executive director of the Pennsylvania Fish & Boat Commission, kept his commitment (and dressed for the weather) to spend two hours with the intrepid crew of Doc Fritchey volunteers who weekly make the trip into Rausch Gap to shovel limestone into the chapter's two Acid Mine Drainage remediation wells.



Schaeffer had been invited to visit the wells after a recent discussion with chapter president Rich DiStanislao, so Dennis Coffman, the leader of the *Stony Valley Gang*, contacted Schaeffer and arranged for the recent, Monday-after-Easter evening visit. The "Gang" goes in the four miles to Rausch Gap every Monday evening to replenish the wells with limestone and to clean and service whatever needs to be serviced. Thanks to lots of early spring rain, the wells are working perfectly, consuming a significant amount of limestone every week. The chapter's diversion well is now in its fourth decade of operation.

We need volunteers to plant fifty trees to replace the previously planted trees that have not survived. We are also going to plant a larger willow tree as a memorial tree for our late friend Dick Puerzer. Thanks to the contributions of several chapter members, we have sufficient money to plant a strategically-located, lasting memorial.

A general email will be sent to the membership in advance of June 11<sup>th</sup>, but if you are not on our email distribution list (about one-third of our membership), then please mark your calendars and join us at 8:30 at the Nolt family's property on Dairy Road for a couple hours of tree planting and assorted streambank restoration work. Park at the North Cornwall Township athletic field which is directly across the street from the TU project.



Volunteers in Action

On Saturday morning August 13<sup>th</sup> at 8:30 AM we are going to take on the challenges presented by downed trees in the special regulations section of Manada Creek. If you have visited the special regs section on Manada, you are

aware that high winds and storms/floods have ravaged the creek bottom; fallen trees have created a real challenge. It is impossible to float stock this section of stream and the downed trees make fly fishing nearly impossible. With the use of chainsaws, winches, pry bars, and strong hands, we plan to open up some of the choked places on this stretch of water.
