From Your President:

Fall is in the air! To me, it's that wonderful time of year to start to slow down and enjoy life. Trout fishing becomes a favorite pastime, with fewer people on the streams, golden afternoon sunshine that warms the soul, and the bright autumn colors painting a beautiful backdrop to the clear waters. Finding fish isn't that difficult, and the trout become a bit more voracious as they prepare for the winter layover.

Even the coloration on the fish is deeper, more intense. I know that we will have a late season stocking on some streams, and there will be some folks chasing these fish, but most streams remain relatively free from competition.

To me, fall and winter are times to plan ahead; spring and summer are the time to implement your plans. Our chapter needs to rethink and rewrite our long-range planning document, which should span a three-to-five year period. As I enter into the final months of my tenure as chapter President, I want to ensure that our organization has a clear direction and groundwork laid to assist the President-Elect, as we will transition to a new chapter Executive Committee in March of 2023.

The chapter's proposed Killinger Creek project has received a handsome grant from the Lower Susquehanna Watershed Association, and thanks to a grant from the Giant Corporation we just purchased a Sonde water quality management device to enable us to remotely track the nuances of the Quittapahilla. Additionally, the chapter has written a comprehensive proposal for steam bank improvements on the upper end of the special regulations area on the Quittie, and we should learn of this decision in November.

Our Diversion Well on Rausch Creek has received its annual maintenance upgrades and the well is functioning perfectly. As I have mentioned before, Manada Creek needs a good work day from our chapter to clear many fallen trees. Just since the start of Fall, we sponsored a wonderful Ladies Day program, staffed informational booths at Wildwood, at the Palmyra Sportsmen's Association Field Day, at National Hunting and Fishing Day, at the Lebanon County Fair, and we will be assisting at the Family Fun Fishing Day at Italian Lake in Harrisburg.

Now it's time to tie everything together into a long-range plan!


Family Fishing Day at Italian Lake

The City of Harrisburg, in conjunction with The Civic Club of Harrisburg, is sponsoring a Family Fishing Day on Saturday, October 22, at Italian Lake in uptown Harrisburg. The lake will be stocked earlier in the week with catfish and bluegills. All participants must be preregistered, and the City of Harrisburg believes that there will be upwards of 300 people fishing. The actual fishing will take place between 10am and noon, and all children must have an accompanying adult with them. Mainly an event to introduce the sport of fishing to urban families, there is a lot of excitement attached to this program. If you don't have any equipment, the Pennsylvania Fish and Boat Commission will provide bait and tackle to anyone who needs it. All participants will need to bring some type of container to store their catch. Our chapter will staff an informational booth at the lake, and we will provide some assistance to help participants. Rivers Conservation and Fly Fishing Camp

If you have a teenage grandchild or child that has shown an interest in conservation and fly fishing, here's a great opportunity to help them this coming summer. The Cumberland Valley Chapter of Trout Unlimited is holding the 28th annual **Rivers Conservation and Fly Fishing Youth Camp June 18-23, 2023**, beginning on Sunday and ending the following Friday. The camp will be at Messiah University in Grantham in Cumberland County. Enrollment is limited to 24 selected qualified students from 14 to 17 years of age.

Although tuition for the week is stated at \$550 per student, that's misleading. That's because the Doc Fritchey chapter will pay the full tuition for up to three students from Lebanon and/or Dauphin County. Your teenager simply has to state in the application that he/she is applying through Doc Fritchey. As soon as the student is accepted, Doc Fritchey will be notified, and we will pay the tuition. It's that simple.

The highly structured curriculum is based on college level classes. Students are instructed in ecology, aquatic biology, geology, hydrogeology, erosion and sediment control, ichthyology, riparian corridor protection, watershed management, entomology, and much more. Students also participate in a hands-on stream habitat improvement project. But it's not all work. There are 10 fishing sessions, casting, and fishing instruction and fly-tying classes. Over 25 instructors, all experts in their field, teach the various classes.

Students don't have to be accomplished fly fishers or budding aquatic biologists to attend; students only need to be motivated and eager to learn.

Ladies Day

On Saturday September 17th our Chapter sponsored our annual educational program to introduce women to flyfishing as a sport and fun family recreational activity. This year's program was again held at the Limestone Springs Preserve located in Richland, Lebanon County. We extend our sincere thanks to DFTU Chapter VP Chuck Swanderski who has been coordinating Ladies Day since 2018. The participants were given instruction and activities in flyfishing gear, equipment, knots and knot tying, entomology, fly tying, and casting. Displays, equipment, and handouts were provided by the Chapter and instructors to enhance the presentations.



Lead instructors were Jacquie Law, Cyndi Camp, Lynn Langer, Steve Long, Brett Wood, Steve Perkins and Rich DiStanislao. Screams and shouts were heard throughout the afternoon when the "students" actually caught fish.

The Brook Trout: Pennsylvania's Misunderstood State Fish

On September 27th, board member Dr. James Suleski presented an informative program at our general membership meeting, held at the Pennsylvania Fish & Boat Commission building. Dr. Suleski takes his brook trout studies seriously and presented a review of outstanding research on our brookie, giving the attendees a layman's term understanding of what it takes to sustain a healthy population of native fish in our local streams. He dispelled some of the beliefs that had been held by the public, such as whether certain streams are considered to be inappropriate to hold brook trout. He pointed to specific studies that proved his statements, and he introduced some definitions that clarify what type of habitat is necessary. Overall, it was an educational experience for everyone. National Hunting and Fishing Day

DFTU was represented by Board Members George Dodson and Chuck Swanderski at National Hunting and Fishing Day at Middle Creek Wildlife Management Area.



The exhibit included posters and information on the DFTU Diversion Well, stream improvement projects, educational events, and fly tying.

Visitors were shown information on insects and tying flies that resemble actual stream insects and bait fish. New to DFTU was the introduction of our QR Code that took participants directly to our website for additional information on projects, educational activities, and how to become a TU member.

Diversion Well News

The diversion well gang has switched to Sunday afternoons at 1:00 PM, every Sunday until spring returns. After a rather dry summer and early fall, rain has finally returned to the Susquehanna Valley and the Stony Valley, so the diversion wells, which have been too long dormant, are now functioning properly. A great crew of 11 Doc Fritchey volunteers showed up for the last Monday evening work session of September and activated the round well.



The crew shoveled in 6 loads of limestone, approximately 1000 pounds. Rainfall recorded that week was 3.95 inches, so the wells are again working to modify the acid mine drainage issues that have plagued Stony Creek for generations. As always, TU members are welcome to visit the wells. Show up at 1:00 PM on Sunday at the entrance to the State Game Lands 211 road on Gold Mine Road and the crew will show you how they operate. Donuts for the crew are always appreciated.

DFTU awarded \$10,000 for equipment to monitor the Quittapahilla Watershed

Thanks to the superb efforts of Dr. Kent Crawford, The Doc Fritchey chapter was awarded a \$10,000 Healing the Planet Grant sponsored by Giant Corp/Giant Foods.

Since receiving the grant money, and with an additional \$2,000 provided by the chapter, DFTU placed an order for a YSI multiparameter water quality sonde. The device will be used to monitor temperature, pH, specific conductance, and dissolved oxygen in the Quittapahilla watershed, primarily on the main stem as it runs through western Lebanon County.

"We can use this device for spot checks, or we can deploy the device long term," Crawford said. "And the long-term application is really important because that means we can put the device in the creek and leave it there. And it records the data for us and stores it in memory. And then, we can come back and retrieve the data from the memory of the device. This is really important because we think that dissolved oxygen in the creek may be a limiting factor for trout. What happens is, in the daytime, if there are algae or plants in the creek, they produce photosynthesis, which generates oxygen. But at night, there's no sunshine, and so photosynthesis cannot occur. And then, respiration still goes on, which consumes oxygen.

Conservation Activities Update

As you have undoubtedly noticed as you have read our 2022 chapter newsletters, we are aggressively seeking grant money for stream restoration projects, mostly now in Lebanon County. Because of the tireless efforts of former chapter president Russ Collins, there is a tremendous amount of activity: grant requests, planning and design, land-owner meetings, and project implementations. Russ gave the board of directors a brief review of the current status, which is summarized below, and it's impressive. Thanks Russ.

Barry farm project - We recently installed groundwater wells to measure the depth of groundwater in the wetlands area where the new stream bed will be created, and also installed stream water temperature monitors to assess whether it is suitable for a thriving brook trout population. Data has been gathered every month since installation.

Snitz Creek 3 - After receiving notice of the grant award, work has begun on this project's design and permitting phase. Invoicing has started through the grant applicant DFTU. A walk-through along the property was done by the chapter's Executive Committee.

Bachman Run - Surveying and wetland delineation have been completed. Stream assessment will wait for winter to be completed due to the heavy overgrowth of wetland grasses.

Snitz Creek 4 - A Growing Greener Grant application was submitted for design and permitting in the amount of \$171,512. Expected award to come in late winter or early spring.

Killinger Creek - Funding for planning, design, and permitting awarded and check received for \$129,084. Assessment has begun, wetlands delineation, and surveying the reach all have been completed.

Shuey project - Habitat structures are now in place, diverters, mudsills, and large boulders have been installed. Construction is complete. Thanks to Lebanon County and the Chesapeake Community CAP program for the funding of this project for \$71,200.

Zimmerman project - Habitat structures are now in place. Root wads and mudsills have been installed. Construction is complete. Thanks to Lebanon County and the Chesapeake Community CAP program for funding this project for \$36,200

Barry Farm Hammer Creek – Our grant application was held for review by DEP. They indicated that a combination of natural stream design and legacy sediment removal should be strongly considered. Working together, we compromised on a solution and our grant application was released on the cusp of the deadline.

Beck Creek – A construction phase grant application has been submitted. We applied for \$795,506, which was the low bid from four solicited contractors. Awaiting Spring 2023 announcement of the award.
